It forms part of the Producer Application & Repayment Agreement, Part 1, and is used to evaluate the eligible advance and shall be maintained in the Producer's file. The total advance issued to one producer must not be greater than \$100,000 Interest Free, and \$400,000 in total including amounts previously issued or attributed to the producer under this program or issued under an overlapping production period.
